This petition is coming on before me for final hearing today in the presence of Mr. Ravinder Prasad Srivatsava - authorised representative of the petitioner and having stood over for consideration till today, this Vidyut Ombudsman passed the following:

ORDER

This petition is registered suo-motu as per Clause 3.42 of Regulation 3 of 2015 of Hon'ble Telangana State Electricity Regulatory Commission for

compliance of the Award passed in Appeal No. 13 of 2021-22 dt.29.07.2022 of this Authority, by the Licensee-respondents.

2. This Authority in the said Award has passed the following order:-

“In the result, the appeal is allowed without costs, setting aside the Award passed by the Forum and declaring the impugned letter as illegal, not valid and without jurisdiction. Accordingly, respondents 1 and 2 are directed not to disconnect the power supply of Service Connection number S010 04052 mentioned in the impugned letter.”

3. Respondent No.2 has filed a letter dt.27.06.2023 stating that they have withdrawn the disconnection notice of the Service Connection of the petitioner. The authorised representative of the petitioner has also submitted that there is no threat of disconnection at present.

4. Heard the authorised representative of the petitioner.

5. The point for consideration is, whether there are sufficient grounds to close the petition?

POINT

6. As seen from the record respondent No. 2 has filed a letter dt.27.06.2023 that they have withdrawn the disconnection notice given to the Service Connection of the petitioner. The authorised representative of the petitioner has also submitted that there is no such threat at present. In view of the compliance of the Award, this petition is liable to be closed.

RESULT

7. In the result, the petition is closed.
