## <u>ORDER</u>

3 of 2015 of Hon'ble Telangana State Electricity Regulatory Commission for compliance of the Award passed in Appeal No. 22 of 2021-22 dt.06.01.2023 of this Authority, by the Licensee-respondents.

2. This Authority in the said Award has passed the following order:-

"In the result, the appeal is allowed, setting aside the Award passed by the learned Forum. The back billing case No. DPE/HYC/SD02/8927/21 demanding Rs.2,85,672/- is set aside. The 1/4th amount of Rs.71,443/- paid by the appellant shall be adjusted in future CC bills immediately. This Authority has no jurisdiction in respect of case No. DPE/HYC/SD02/9355/21 booked under Sec.126 of the Act demanding Rs.46,833/-".

- 3. Respondents 2 to 4 have filed compliance reports.
- 4. Today the appellant (petitioner) is absent. Respondents 1 and 2 are present.
- 5. Heard the respondents.
- 6. The point for consideration is, whether there are sufficient grounds to close the petition?

## **POINT**
