This petition is coming on before me for final hearing today in the presence of the appellant virtually and Sri G. Ravinder - AE/OP/Rural Palvoncha and Sri J. Laxman - ADE/OP/Palvoncha representing the respondents virtually and having stood over for consideration, this Vidyut Ombudsman passed the following:

ORDER

This petition is registered suo-motu as per Clause 3.42 of Regulation 3 of 2015 of Hon'ble Telangana State Electricity Regulatory Commission for compliance of the Award passed in Appeal No. 46 of 2023-24 dt.05.01.2024 of this Authority, by the Licensee-respondents.

2. This Authority in the said Award has passed the following order:-

“In the result, the appeal is allowed in part and a sum of Rs.7,000/- (Rupees seven thousand only) is granted as compensation to the appellant. This is in addition to the compensation of Rs.3,000/- already granted by the learned Forum. The Superintending Engineer/Operation/Bhadradi Kothagudem is directed to recover the compensation amount of Rs.7,000/- (Rupees seven thousand only) from the concerned officers who caused delay in releasing the service. If the said delay is caused due to non-availability of materials at stores of Licensee, the compensation shall be borne by the Licensee, and the same may be adjusted against the future CC bills of Service Connection No. 02104-01733, Category-III. Compliance shall be reported within (30) days from the receipt of copy of this Award.”

3. Respondent No.3 has already filed a compliance report.
4. Heard the appellant and respondents 1 and 2 virtually.
5. The point for consideration is, whether there are sufficient grounds to close the petition?

POINT

6. Respondent No.3 has filed a compliance report giving credit of Rs.7,000/-(Rupees seven thousand only) to the account of the appellant/petitioner. This is confirmed by the appellant/petitioner. In view of the compliance of the Award, this petition is liable to be closed.

RESULT

7. In the result, the petition is closed.
