AWARD

Whereas the appellant filed an Appeal on 17-02-2018 against the order of the Consumer Grievances Redressal Forum, TSSPDCL in CG no. 500/2017-18 of SDPT circle dt: 25-10-2017.

2. Whereas in terms of Clause 3.23 of the Regulation No.3 of 2015 of the electricity regulatory commission, Telangana state the vidyut ombudsman is required to make and endeavour to promote settlement by mutual agreement between the

parties.

- 3. Appellant pleaded to pay balance interest on consumption deposit of Rs 13,91,082 @ twice rate of interest 15.50% per annum pertaining to FY 2016-17 based on the clause 3.35 of regulation 3 of 2015.
- 4. The Appellant filed a MEMO dt.10.05.2018 mentioning that he is withdrawing the appeal. Hence the appeal is closed as withdrawn.
