Shreyan - AE/OP/Sangareddy Town - II for the Respondents and having considered the record and submissions of both parties, the Vidyut Ombudsman passed the following;

AWARD

Both parties present. Heard both. During the course of the arguments it has come to the notice of the Ombudsman that the Respondents have not maintained the distance of 3.9" feet from the boundary line of the Appellant's plot.

Hence the Respondents are directed to shift the pole or poles to a distance of 3.9 feet along the plot of the Appellant as per the provisions of Indian Electricity Rules and the concerned police are directed to provide protection to the Respondents while shifting the pole and the Respondents are directed to report by 06.08.2019 regarding compliance.
