Saraswathi - Impleaded Respondent for the Respondents and having considered the record and submissions of both the parties, the Viduyut Ombudsman passed the following;

AWARD

Appellant, Respondent Nos. 1 to 4 and the impleaded Respondent No.6 are present. The documents on record and the oral representations shows that the Appellant filed a suit vide O.S.No. 2247/2017 for specific performance against the Respondent No.6 and others while the Sister and Nieces of Respondent No.6 filed a suit

for partition against the Respondent No.6 and others (though the Suit number is not provided in the documents) with regarding to the property in which there is a dispute regarding the disconnection of service meter, on which the Appellant approached this office.

Hence, in the said circumstances as the subject matter was located in the property that is seized by Civil Court in view of the Title dispute, this Office has no jurisdiction to entertain or adjudicate in the matter.
