AWARD

Appellant not present in spite of notice. Respondents are present. Hence perused the records and heard the Respondents.

The records filed by the Appellant himself and the Respondents apart from the arguments of the Respondents clearly shows that there are long pending disputes between the Appellant and the Respondents and the Appellant failed to comply with the orders of the Vidyut Ombudsman in the connected matters pertaining to his service connection No.15000 01192.

At this stage Appellant appeared.

In the present case the appellant is alleged to have committed theft of Electricity as per the Respondents apart from other allegations.

Hence in the said circumstances I am of the opinion that the Ombudsman is not having jurisdiction to entertain this petition in view of the allegations of theft by the Appellant. Hence, the Appeal is rejected.
