The above appeal originally filed on 15.09.2014 coming up for hearing before the Vidyut Ombudsman, Telangana State on 26.06.2015 at Hyderabad in the presence of Sri. L. Anil Kumar - DE/OP/MBNR, R. Ananda Reddy - ADE/OP/Kodangal,

K.Srinivasulu- AE/OP/Doulthabad for the Respondents and the Appellant was absent in spite of intimation of the hearing, and having considered the record and submissions of both the parties, the Vidyut Ombudsman passed the following;

## AWARD

No representation on behalf of the Appellant. The respondents 1 to 3 are present. Heard. The AAE & ADE filed a report stating that the Appellant Sri. Matike Rayappa had been using unauthorised service and had applied for regulating his service and for LT Line too in the month of January 2014. There is an allegation that the lineman by name Mr. Keshava Reddy had demanded Rs 2000/- to manage the sanction of the line. The AE represents that soon they got this information, they have terminated the service of the temporary employee Sri. Keshava Reddy from the service and now he is no more in any service.

2. The Appellant sent a letter Dt. 25-1-2015 stating that the same lineman Sri. Keshava Reddy had tried to fix the wires and then he (Appellant) noticed that his borewell totally gave in and filled up. The Appellant stated that after he gets a fresh borewell dug, he would get the power connection to his well. The Appellant was contacted on phone by the office of the Vidyut Ombudsman and got the contents of his letter Dt. 25-01-2015 confirmed. The Appellant requested the matter under Appeal be closed. Hence the Appeal is closed as settled out of the present forum.
