Appeal No. 5/2020: MP No. 5/2020: Sri.N.Ravi Babu Vs. TSSPDCL

Heard the applicant and the officers of the opposite party, the grievance is with regard to non-implementation of the order of this authority, earlier interim order has been passed for restoring power supply. However in today's hearing the representatives of the opposite party have stated that they have filed a writ petition in the Hon'ble High Court in WP no 18982 of 2020 against the order of CGRF in CG no 578 of 2019 -20 of TSSPDCL-I. It is noticed that there is no stay granted to the opposite parties by the honorable high court. In the circumstance the parties have been directed to place the status report regarding the payments and the power supply position. The appellant is required to pay their current consumption bills including the arrears. Any other issues cannot be considered in this appeal .The applicant is required to inform as to what is the amount the appellant is willing to pay for continuations of supply then only further decision can be taken on the application.
