### **ORDER**

This petition is registered suo-motu aggrieved by non - implementation of the Award passed in Appeal No. 28 of 2025-26 dt.20.11.2025 of this Authority, by the Licensee-respondents.

2. This Authority while allowing the appeal, at para No. 24 of the said Award has passed the following order:-

“In the result the appeal is allowed in part by setting aside the impugned Award and the assessment of revenue loss contributing to the random nature of intermittent R-Phase voltage missing is revised to Rs.17,862/- (Rupees seventeen thousand eight hundred and sixty two only) instead of (137) days..”

3. Respondent No.3 has filed a report stating that the Award passed by this authority is complied with.

4. Heard both sides.

5. The point for consideration is, whether there are sufficient grounds to close the petition?

### **POINT**

6. As seen from the record, respondent 3 has filed a compliance report stating that the Award has been implemented. In view of the compliance of the Award, I hold that there are sufficient grounds to close the petition.


## RESULT
