ORDER

This petition is opened suo-motu aggrieved by non - implementation of the Award passed in Appeal No. 37 of 2024-25 dt.21.01.2025 of this Authority, by the Licensee-respondents.

2. This Authority while allowing the appeal, at para No. 21 of the said Award has passed the following order:-

“In the result, the appeal is allowed by setting aside the impugned Award passed by the learned Forum and consequently the Final Assessment Order is set aside. The amount of Rs.58,000/- (Rupees fifty eight thousand only) paid by the appellant shall be adjusted towards the electricity arrears of the subject Service Connection. The respondents shall file compliance within (15) days from the date of receipt of copy of this Award.”

3. It is reported by respondent No.2 that the Award passed by this authority is complied with.

4. Heard both sides.

5. The point for consideration is, whether there are sufficient grounds to close the petition?

6. As seen from the record, the respondents have filed a compliance report stating that the Award has been implemented. In view of the compliance of the Award, this petition is liable to be closed.


RESULT
