ORDER

This petition is registered aggrieved by non-implementation as per Clause 3.42 of Regulation 3 of 2015 of Hon'ble Telangana State Electricity Regulatory Commission for compliance of the Award passed in Appeal No. 02 of 2024-25 dt.22.04.2024 of this Authority, by the Licensee-respondents.

2. This Authority while allowing the appeal, at para No. 21 of the said Award has passed the following order:-

"In the result, the appeal is allowed by setting aside the impugned Award of the learned Forum consequently the back billing notice demanding back billing amount of Rs. 9,54,127/- is set aside."

- 3. Heard both sides. It is submitted that the W.P.No.16196 of 2024 was already filed.
- 4. The point for consideration is, whether there are sufficient grounds to close the petition?

POINT

5. As seen from the record, aggrieved by the impugned Award of this Authority, the respondents have preferred W.P.No.16196 of 2024 before the Hon'ble High Court for the State Telangana at Hyderabad. In view of the filing of the writ petition, I hold that there are sufficient grounds to close the petition.

RESULT

6. In the result, the petition is closed.
