The above appeal filed on 22.01.2019, coming up for final hearing before the Vidyut Ombudsman, Telangana State on 07.03.2019 at Hyderabad in the presence of Sri. M. Sridhar - On behalf of the Appellant Company and Sri. K. Hanuma - SAO/OP/Nalgonda and Sri. Sunil Kumar - DE/EBC/Corp.Office - was present for the Respondents and having considered the record and submissions of both the parties, the Vidyut Ombudsman passed the following;

AWARD

This is an Appeal against the orders of the CGRF Nalgonda Circle in CG No.261/2018-19 dt.28.11.2018, seeking for revision of Open Access final settlement bill for the HT SC No. NLG-162 for the months of May, 2016 and June,2016.

Today when I was perusing the records, it has come to my notice that the Appellant mentioned the Writ Petitions i.e. W.P.No 24904/2016 and W.P.No.10577 of 2017, but neither referred to these petitions before the CGRF nor before the

Ombudsman. Hence after referring to the High Court website, I found that W.P.No.10577/17 which is disposed of by Hon'ble High Court was not pertaining to the connected matter to this Appeal, while W.P.No.24904 of 2016 is pertaining to this appeal and the same is pending as on today. The order of CGRF also shows that the pendency of Writ Petition to this Appeal was not brought to its notice and hence CGRF disposed the CG NO.261/18-19 without taking into consideration the pendency of the Writ.

Since the subject matter of this Appeal is already seized by Hon'ble High Court in the W.P.No.24904 of 2016, these proceedings are closed.
